The lady instantly started trying to build some weird kind of scamming friendship with me by talking about my name and age then saying she was the same age as me (which the first scamming lady who pressured me into the policy in the first place said) i told her i wanted it cancelled TODAY. She then went on talking about the company and policies and all the great cover which i did not want to hear i told her to cancel it, that i just want to cancel it. She continued trying to talk me into not cancelling it. They do the people DO NOT accept that you want to cancel the policy! Seems like a complete scam because i have never even signed any paperwork to accept their policy they mailed it to me but i never signed it and sent it back!!! Yet somehow it exists and soon i'm going to be charged money for it! I told the lady i have NO income because i don't, i'm a student and the first lady pressured me into the policy even though i have NO income. After about 20 minutes just repeating myself saying i want it cancelled right now they finally said "ok it's cancelled" but that they would send me something in the mail that i need to sign and post back. They did this when i was "starting" the policy and said the policy would not be taken out fully until i signed paperwork and sent it back to them but I NEVER DID. I never signed up to this crap!
