PURSUANT TO SECTION 6D(3)**

Pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth), I direct that so much of the contents of the statement of evidence of Donald Mark Sillar provided to the Commission in respect of Rubric 2-31, and the documents proposed to be exhibited to that statement, as discloses:



 - (v) the figures at .0045 after each instance of "Benchmark –" in clause 13.1(b);
 - (vi) the percentage figures at .0045 in the second paragraph of clause 14.1;
 - (vii) the table at .0056;
 - (viii) the percentage figures at .0056 under the heading "Disengagement";
 - (ix) the percentage figures at .0057 appearing under the heading "Adviser" and under the heading "Maximum", except for 5.125%;
 - (x) the tables and figures in the headings at .0059;



- (xi) the tables and figures in the headings at .0060;
- (xii) the figure in the asterisked sentence at the foot of .0060;
- (xiii) the percentage figures in the table entitled "Insurance fees" at .0061;
- (xiv) the content of the column entitled "Adviser" in the table entitled "Share fees" at .0061-0062;
- (xv) the percentage figures under the heading "Fund manager rebates" at .0062;
- (xvi) the first table at .0063; and
- (xvii) the content of the columns entitled "Adviser" and the name of the "Promoter" in the second table at .0063,

not be published except to the Commission, its staff and counsel and solicitors assisting the Commission, and to ANZ and its counsel and solicitors.
