**NON-PUBLICATION DIRECTION  
PURSUANT TO SECTION 6D(3)**

Pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth), I direct that so much of the contents of the statement of evidence of Ms Kate Gibson provided in response to Rubric 3-7, and the documents exhibited to that statement, as discloses:


- (a) contact and identifying information of customers of Australia and New Zealand Banking Group Limited and its associated entities (within the meaning of that term as defined in s 50AAA of the *Corporations Act 2001* (Cth)) (collectively, **ANZ**);
- (b) contact and identifying information of customers of any third parties;
- (c) direct contact information and signatures of employees of ANZ and employees of any third parties;
- (d) the information identified in Appendix A and Appendix B of ANZ's application for non-publication directions dated 9 May 2018 (**ANZ Application**), except for:
  - i. in relation to KGG-7, the information identified by reference to pages 38-39, 55-57 and 67-68 of that document in the ANZ Application;
  - ii. in relation to KGG-8, the information identified by reference to page 18 of that document in the ANZ Application;
  - iii. in relation to KGG-10, the information identified by reference to page 13 of that document in the ANZ Application;
  - iv. in relation to KGG-13, the information identified by reference to pages 44-45, 61-63 and 74 of that document in the ANZ Application;
  - v. in relation to KGG-16, the information identified by reference to page 4 of that document in the ANZ Application;
  - vi. in relation to KGG-24, the information identified by reference to pages 6 and 16 of that document in the ANZ Application;



- vii. in relation to KGG-25, the information identified by reference to pages 12, 18-40 and 40 of that document in the ANZ Application; and
- viii. in relation to KGG-26, the information identified by reference to page 12 of that document in the ANZ Application;
- (e) in relation to KGG-10, the information identified in Appendix A of ANZ's further application for non-publication directions dated 21 May 2018, except for the information identified by reference to page 4 of that application; and
- (f) identifying information of any individuals against whom allegations of misconduct have been made, or, in respect of whom, in the context of the particular document, it is suggested have been involved in misconduct,

not be published except to the Commission, its staff and counsel and solicitors assisting the Commission, to ANZ and its counsel and solicitors.
