PURSUANT TO SECTION 6D(3)**


Pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth), I direct that so much of the contents of the statement of evidence of Mr Tony Colin Tapsall provided to the Commission in respect of Rubric 4-13, and the documents exhibited to that statement, as discloses:

- (a) contact and identifying information, personal information and signatures of customers of Australia and New Zealand Banking Group Limited and its associated entities (within the meaning of that term as defined in s 50AAA of the *Corporations Act 2001* (Cth)) (collectively, **ANZ**);
- (b) direct contact information and signatures of employees of ANZ, including email addresses for mailboxes and other contact information for certain teams within ANZ, which are used only for internal purposes; and
- (c) so much of footnotes 15 and 16 and paragraphs 53, 54(b), 80, 98 and 99 of the statement that are subject of the application by ANZ for directions pursuant to s 6D(3) of the Act dated 18 June 2018 (**the second application**);
- (d) the postcode specified in the last sentence of paragraph 59 of the statement;
- (e) so much of the parts of:
 - (a) ANZ.800.634.2095 (being Exhibit TCT-7);
 - (b) ANZ.800.634.2392 (being Exhibit TCT-8);
 - (c) ANZ.800.634.3085 (being part of Exhibit TCT-9);
 - (d) ANZ.800.634.3214 (being part of Exhibit TCT-10);
 - (e) ANZ.800.648.0001 (being part of Exhibit TCT-12);
 - (f) ANZ.800.728.0001 (being part of Exhibit TCT-19); and
 - (g) ANZ.800.715.0819 (being part of Exhibit TCT-21),that are subject of the application by ANZ for directions pursuant to s 6D(3) of the Act dated 6 June 2018 (**the first application**) or the second application; and
- (f) the second percentage figure on ANZ.800.634.3072 at 3077 (being Exhibit TCT-9) that is subject of the first application,
