PURSUANT TO SECTION 6D(3)**


Pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth), I direct that so much of the contents of the documents in Schedules A and B as discloses:

 - iii. Mr Tom Campbell's name,
 - iv. Mr Paul Wright's name,
 - v. Ms Marina Wright's name,
 - vi. Mr Timothy Wright's name,
 - vii. Ms Caroline Herring's name,
 - viii. the names of the properties "Kia-Ora", "Jamberoo" and "Nankeen"; and
 - ix. the towns and States of the properties referred to in paragraph (viii);
- (b) identifying information of any individuals against whom allegations of misconduct have been made, or, in respect of whom, in the context of the particular document, it is suggested have been involved in misconduct; and
- (c) in relation to RAL.0005.0005.0043 and RAL.0005.0003.0072, the information identified as commercially sensitive in Rabobank's application for non-publication directions dated 22 June 2018,

not be published except to the Commission, its staff and counsel and solicitors assisting the Commission, and to Rabobank and its counsel and solicitors.
