**NON-PUBLICATION DIRECTION
PURSUANT TO SECTION 6D(3)**

Pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth), I direct that so much of the contents of the documents identified in the Schedule as discloses:

- (a) contact and identifying information of customers of Bendigo and Adelaide Bank Limited and its associated entities (within the meaning of that term as defined in s 50AAA of the *Corporations Act 2001* (Cth)) (collectively **BAB**);
- (b) the direct contact information and signatures of employees of BAB or employees of any third parties;
- (c) identifying information of any individuals against whom allegations of misconduct have been made, or, in respect of whom, in the context of the particular document, it is suggested have been involved in misconduct;
- (d) in relation to BAB.5006.0004.0070:
 - a. at page .0076, the first line immediately under the heading 'Declarations of pecuniary/conflicts of interest';
 - b. at pages .0086 and .0087, the information identified by BAB as commercially sensitive in its application for non-publication directions dated 25 June 2018, except for the heading 'Summary' and the four paragraphs immediately below that heading;
- (e) in relation to BAB.5031.0001.0002, pages .0015, .0060-.0061, 0068-.0072, .0074, .0076 and .0078;
- (f) in relation to BAB.5024.0001.1708, the third paragraph of page .1708;
- (g) in relation to BAB.5032.0003.0278, the third paragraph of page .0278;
- (h) in relation to BAB.5034.0001.0026, the third paragraph of page .0026;
- (i) in relation to BAB.5035.0001.0022, the third paragraph of page .0022, and the heading under the fourth dot point on page .0023, and the paragraph immediately following that heading on page .0023;




(j) in relation to BAB.5035.0001.0001, the first dot point in the second paragraph of page .0001; and

(k) in relation to BAB.5034.0001.0001, the third paragraph on page .0001,

not be published except to the Commission, its staff and counsel and solicitors assisting the Commission, and to BAB and its counsel and solicitors.
