
**NON-PUBLICATION DIRECTION
PURSUANT TO SECTION 6D(3)**

Pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth), I direct that so much of the contents of the statement of evidence of Peter Kell provided to the Commission in respect of Rubric 5-61, and the documents exhibited to that statement, as discloses:

- (a) identifying information of any individuals against whom allegations of misconduct have been made, or, in respect of whom, in the context of the particular document, it is suggested have been involved in misconduct; and
- (b) those parts of paragraphs 328-333 of Mr Kell's statement the subject of the application for a direction pursuant to s 6D(3) of the *Royal Commissions Act 1902* (Cth),

not be published except to the Commission, its staff and counsel and solicitors assisting the Commission, and to the Australian Securities and Investments Commission and its counsel and solicitors.
