PURSUANT TO SECTION 6D(3)**

  - (viii) the number and second appearing percentage figure in the first dot point at .0185;
  - (ix) the last sentence of the first paragraph at .0185;
  - (x) the paragraph appearing under the heading "Choice" at .0185;
  - (xi) the third paragraph under the heading "Key issues and considerations" at .0185;
  - (xii) the second sentence of the fourth paragraph under the heading "Key issues and considerations" at .0185;
  - (xiii) the words between the commas in the last line at .0185;
  - (xiv) the five dot points at .0186;
  - (xv) the words after the comma in the last sentence of the second last paragraph at .0186; and
  - (xvi) the column closest to the left in relation to AMP & SST (and no other column) at .0187;
- (i) the documents listed in the Schedule as discloses contact and identifying information of customers of the AMP Group and customers of any third parties;
- (j) the documents listed in the Schedule as discloses direct contact information of employees of the AMP Group and employees of any third parties;



- (k) the documents listed in the Schedule as discloses the names of any employers who currently have corporate superannuation plans with the AMP Group, including any mandate amounts relevant to those employers;
- (l) the documents listed in the Schedule as discloses the names of any corporate authorised representatives of the AMP Group,

not be published except to the Commission, its staff and counsel and solicitors assisting the Commission, and to the AMP Group and its counsel and solicitors.
