### 6. DECLARATION

- your referee(s); your employer;
- your representative (for example your lawyer, mortgage broker, attorney or executor).

Where relevant, ANZ may also give your personal information (including information about your credit worthiness, history, standing or capacity) to:

- any credit reporting agency; any contractor or service provider ANZ engages to carry out or assist its functions and activities;

- any credit provider insofar as your personal information is given:
  - to assess your credit application;
  - to assess your credit worthiness;
  - to help you avoid a default on your obligations;
  - to tell a credit provider of any default you have made; or
  - for any other purpose you agree to.

Where you do not want the ANZ Group or ANZ's alliance partners to tell you about their products or services, you may withdraw your consent by calling 13 13 14.

#### Accessing your personal information held by ANZ

Subject to the provisions of the Privacy Act, you may access your personal information at any time by asking to do so at any ANZ branch or by calling 13 13 14. ANZ may charge you a reasonable fee for access. If you can show that information about you is not accurate, complete and up to date, ANZ must take reasonable steps to ensure it is accurate, complete and up to date.

#### Personal information
